## **Guide to filling out the form (Please read this)**

If you have only lived a short period in Norway before reaching 67 years of age, you may be eligible for supplementary benefit. When applying for supplementary benefit you must go to your local NAV office and bring your passport and other travel documents with you. (A copy of identification papers is not enough). Before you submit your application, you must read the information about supplementary benefit at [nav.no](http://nav.no).

### **Section 1 Personal information**

Only use "single" as a marital status if you have never been married. If you are not divorced, but the financial and social ties between you and your spouse/registered partner have been permanently severed, you are considered to be living "apart". The same applies if your spouse/registered partner resides permanently in a nursing or retirement home. You must inform whether you are living with another adult, e.g. children, grandchildren or other adults. To be eligible for supplementary benefit you must have a permanent residence permit and be resident in Norway. You will lose the right to supplementary benefit if you live abroad for more than 90 consecutive days or for more than 90 days in total during the benefit period.

### **Section 2 Information about your spouse/cohabitant/other adult, if you are living together**

If you are living together with your spouse, cohabitant or registered partner, you must state their name and national ID no. in this section. If you are single and living together with another adult, you do not need to state his or her national ID no.

### **Section 3 Information about resident permit**

You must fill out this field. If you came to Norway and were granted a resident permit on the grounds of family reunification with your adult children, grandchildren, nephew or niece and you were also required to have a person guarantee that he/she would provide for you, you must submit a copy of the first resident permit. From 1 January 2016, applicants who come to Norway on these grounds will no longer be eligible for supplementary benefit.

### **Section 4 Information about pensions and other income**

You must fill out this section if you have earned income, income from capital or other assets, pension income or other social security benefits other than child benefit, child support and basic and attendance benefit. If you are receiving several types of pension, you must specify which and state the amounts. You must include Norwegian and foreign income. You must state the gross amounts before tax.

If you are self-employed, you must state your estimated personal income under the provisions of the Norwegian Tax Act (before tax). If you have a personal and earned income, you must state both amounts.

Supplementary benefit will be granted if the full supplementary benefit is higher than your total income. The benefit will be the difference between these amounts.

### **Section 5 Information about your spouse/cohabitant or registered partner's pensions and other income**

You must fill out this section if your spouse, cohabitant or registered partner has an earned income, income from capital or other assets, pension income or other social security benefit other than child benefit, child support and basic and attendance benefit. See also the guide for section 4.

### **Section 6 Information about assets**

You must fill out this section if you or your spouse, cohabitant or registered partner have assets. Financial assets means the total cash, bank deposits, negotiable securities, bonds, units in securities funds, other transferable securities, accounts receivable, etc.

You must also include assets in the form of a valuable residence, holiday home, other property or objects of significant value. Do not include assets in the form of a standard residence.

### **Section 7 Information about financial benefit (Social benefit)**

If your spouse, cohabitant or registered partner is receiving financial benefit, you must state this here.
